9. HOUSEHOLD HAZARDOUS WASTE (HHW), ORGANIC WASTE, AND OTHER SOLID WASTE ISSUES – INFORMATION AND POSSIBLE ACTION ITEM(S)

A. HHW Participation Reports - Information Item

General Manager Eggart informed the Board that HHW Participation reports will be presented at a future meeting.

Board Member Morasco left the meeting at approximately 10:00.

B. Legislative Update – Information and Potential Action Item

General Manger Eggart informed the Board that the new legislative sessions had just begun and briefly discussed some of the relevant two-year bills that stalled in the prior legislative session, but which might be reconsidered in the current session. These included SB 54 and AB 842 to regulate single-use plastics; AB 1371 to prohibit online retailers from using singleuse plastic packaging; AB 478 relating to thermoform plastic containers; SB 289 to create an ERP program for batteries and battery-embedded products. General Manager Eggart also provided information about an initiative measure that has qualified for the November 2022 ballot, which would require CalReclye to adopt regulations to reduce plastic waste by requiring that single-use plastic packaging, containers, and utensils be reusable, recyclable, or compostable in order to achieve a 25% reduction in such waste by 2030, prohibiting polystyrene container use by food vendors, and taxing producers of single-use plastic packaging, containers, and utensils.

C. Update on HHW Issues, Organic Waste Disposal Issues, and Other Potential Future Issues – Information Item

General Manager Eggart provided information to the Board and City staff regarding the SB 1383 Local Assistance Grants, informed the Board that he was in the process of scheduling a meeting with the RSWA City Program Managers to discuss potential collaboration and RSWA's role, and advised the Board that he was in the process of reaching out to CalRecycle to determine if RSWA is eligible to be a grantee. Roberta Goldenpenny of CalRecyle also answered questions from the Board.

Board Member Blakespear suggested that the Board have a future discussion about adding staff to RSWA can do more things.

Board Member Morasco returned to the meeting at approximately 10:21.

Resolution No. 2022-02

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE REGIONAL SOLID WASTE ASSOCIATION MAKING SPECIFIED FINDINGS AND RE-AUTHORIZING REMOTE TELECONFERENCE MEETINGS IN ACCORDANCE WITH GOVERNMENT CODE SECTION 54953(e)(3).

WHEREAS, the Board of Directors of the Regional Solid Waste Association ("RSWA") holds regular and special public meetings pursuant to the Ralph M. Brown Act (the "Brown Act"), Government Code section 54950, et seq.

WHEREAS, pursuant to RSWA's Bylaws, the designated location for regular meetings of the RSWA Board of Directors is the Fletcher Cove Community Center in the City of Solana Beach.

WHEREAS, on September 16, 2021 Governor Newsom signed Assembly Bill ("AB") 361, which added subsection (e) to Government Code section 54953 and makes provision for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions.

WHEREAS, a required condition of AB 361 is that a state of emergency is declared by the Governor pursuant to Government Code section 8625.

WHEREAS, on March 4, 2020 Governor Newsom declared a State of Emergency in the State of California pursuant to Government Code section 8625 as a result of the threat of the Coronavirus (COVID-19) pandemic, and the State of Emergency is still in effect.

WHEREAS, in addition to the Governor's proclamation of a State of Emergency, as a result of the COVID-19 pandemic, the City of Solana Beach has declared a local emergency and has closed all nonessential City facilities, including the Fletcher Cove Community Center, to ensure the safety of the public.

WHEREAS, on October 7, 2021, the RSWA Board of Directors adopted Resolution No. 2021-05 making findings in accordance with AB 361 and Government Code Section 54953(e) and authorizing the use of remote teleconference meetings.

WHEREAS, as a condition of extending the use of the provisions found in Government Code Section 54953(e), the Board of Directors must reconsider the circumstances of the State of Emergency and make specified findings at least every 30 days.

WHEREAS, on October 28, 2021, November 18, 2021, December 9, 2021, and January 6, 2022, the RSWA Board of Directors reconsidered the circumstances of the State of Emergency and adopted Resolutions No. 2021-07, 2021-08, 2021-09, and 2022-01, respectively, making specified findings and re-authorizing remote teleconference meetings in accordance with Government Code Section 54953(e).

WHEREAS, sustained COVID-19 community transmission continues to occur in San Diego County and the cities within RSWA's jurisdiction and various state and local officials continue to recommend measures to promote social distancing.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Directors of the Regional Solid Waste Association as follows:

1. The above findings and recitals are true and correct and are incorporated herein in full by this reference.

2. The Board of Directors of the Regional Solid Waste Association has reconsidered the circumstances of the proclaimed State of Emergency in California and has determined that (a) the State of Emergency continues to directly impact the ability of the members of the Board to meet safely in person and (b) state and local officials continue to recommend measures to promote social distancing.

3 That during the effective period of this Resolution, members of the Board of Directors of the Regional Solid Waste Association may continue to participate in meetings subject to the Brown Act by way of videoconference and/or teleconference in accordance with Assembly Bill 361 and Government Code section 54953(e).

4. The RSWA General Manager is authorized and directed to take all actions necessary to carry out the intent and purpose of this Resolution, including, conducting open and public meetings in accordance with Government Code Section 54953(e) and other applicable provisions of the Brown Act.

5. This Resolution shall take effect immediately upon its adoption and shall be effective until the earlier of: (1) March 5, 2022; or (2) such time the Board of Directors adopts a subsequent resolution in accordance with Government Code Section 54953(e)(3) to extend the time during which the Board may continue to hold virtual or teleconferenced meetings without complying with Government Code Section 54953(b)(3).

Subject: Parameters for Adding New Parties to RSWA and Collaborating with Non-Member Agencies

Date: February 3, 2022

BACKGROUND/DISCUSSION

In January, staff from the City of La Mesa inquired of the General Manager about potentially joining RSWA and/or collaborating with RSWA on SB 1383 issues. In May 2021, staff from the City of San Marcos made a similar inquiry. RSWA does not have any established policies regarding adding members or collaborating or sharing information and RSWA work product with non-member cities. Secretary Worden previously requested that these matters be agendized for discussion by the Board. Other Board Members have also previously expressed interest in exploring the expansion of RSWA.

Section XVIII of the RSWA Joint Powers Agreement provides that additional public entities may become parties to RSWA upon such terms and conditions as may be set forth in a resolution adopted approved by a majority of the Members of the RSWA Board. In addition, pursuant to Section V of the Joint Powers Agreement, another public entity may participate in RSWA by becoming a "Special Contract Party." The scope of a Special Contract Party's participation in RSWA, along with the rights and obligations of the agency and RSWA, are determined by the terms of a special contract negotiated between and approved by RSWA Board. Escondido is a Special Contract Party of RSWA for HHW purposes only.

In addition, nothing prohibits RSWA from entering into contracts and/or otherwise collaborating or sharing information with other public agencies that are not Parties to the RSWA Joint Powers Agreement or Special Contract Parties for the purposes of advancing mutually beneficial interests. If RSWA is going to regularly do so, however, it may be prudent for the Board to adopt uniform policies and/or procedures establishing parameters for such collaboration and/or information sharing and providing direction to Staff in pursuing these relationships.

RECOMMENDED ACTION

It is recommended that the Board discuss these issues and provide direction to the General Manager / General Counsel. The Board may also wish to establish an ad hoc subcommittee of no more than three (3) of its Members to meet separately to develop recommended policies for the full Board's consideration.
